IN CONSIDERATION of being permitted to participate in any way in the sport and activities of a TagParty™, under the auspices of TagParty, the named participant (the "Participant"), and the Participant's parent or guardian, if the Participant is under the age of 18 years, acknowledge, appreciate, and agree that:

While personal discipline will minimize this risk, the risk of serious injury does exist; I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown and assume full responsibility for my participation; and,
